# Letter from the Director



It's hard to believe that two years have passed since the voters of Minnesota approved the Clean Water, Land and Legacy Amendment on November 4, 2008, and created the Arts and Cultural Heritage Fund. Since the passage of this landmark action, the Minnesota Historical Society has taken its responsibility very seriously as we have carried out the intention of the Legacy Amendment.

While the time has gone quickly and the work has been immense, the progress and outcomes have been tremendously satisfying. In this report you'll read about significant accomplishments: 474 grants received by 343 organizations across Minnesota; more than 40 new statewide historic programs that are reaching new audiences using interactive technology and innovative training methods; more than 25,000 historic images and resources available digitally for the first time; partnerships with more than 50 other history-minded organizations, all focused on fostering education and preserving our legacy.

The sheer volume of these initiatives is impressive. However, what's more important is the impact our work is having on individual lives—citizens in every county, young and old alike; those who love history and those who are being exposed to it for the first time, including:

- The student who is inspired to learn more after history comes alive for him in the classroom through a live, interactive video conferencing program featuring the explorations of French cartographer Joseph Nicollet
- The genealogist who discovers a new descendant because a historical newspaper has been digitized and the story is now available online
- The Ojibwe elder who is able to share and save her native language for future generations through the Ojibwe People's Dictionary

We are pleased to provide the Legislature and the Governor with this report, which shares some of these stories, along with details of each of the grants, projects, partnerships and exhibits funded through the Arts and Cultural Heritage Fund that are making a difference across Minnesota.

As we move forward, we would like to express our appreciation to the people of Minnesota. We respectfully ask the Governor and the Minnesota Legislature to renew the funding commitment to history programs and projects through the Minnesota Historical Society. Through our work, we believe Minnesotans across the state will have an unprecedented ability to preserve their history for many years to come and to provide a true legacy gift to future generations.

# Overview

Each January, the Minnesota Historical Society is required to report to the governor and legislature all expenditures made from the Arts and Cultural Heritage Fund (ACHF). This report details all ACHF projects and programs funded through the Society for the 2010–2011 biennium.

## Background

On November 4, 2008, the voters of Minnesota approved the Clean Water, Land and Legacy Amendment to preserve some of the most important elements that make Minnesota what it is today.

This amendment to the Minnesota constitution is sometimes referred to as the “Legacy Amendment” and mandates that a portion of the funding be used *“to preserve Minnesota’s history and cultural heritage.”*

## Minnesota History Coalition

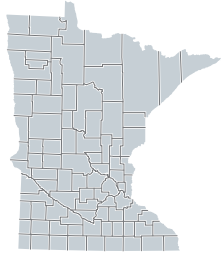
After the passage of the Legacy Amendment, representatives of various state history organizations formed an advisory group called the Minnesota History Coalition. The Coalition held a series of town hall meetings across the state to gather ideas on how Legacy funding should be used.

Ultimately, the Coalition created recommendations aimed at furthering the educational and economic development benefits of historical work in our state. The Coalition presented its recommendations to the legislature, forming the conceptual basis for the 2009 appropriations.

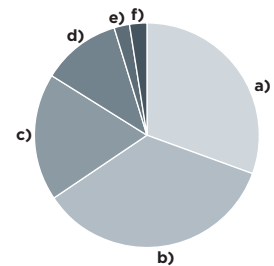

### Appropriations

The Legacy Amendment dedicates 19.75 percent of overall Legacy funding to the Arts and Cultural Heritage Fund. The 2009 legislature appropriated \$22 million from the ACHF to the Minnesota Historical Society for the two-year period July 2009–June 2011.

The legislature directed that the funding be used for projects that “preserve and enhance access to Minnesota’s history and its cultural and historical resources.” It divided the \$22 million into six categories:

a) Historical and Cultural Heritage Grants Program (pgs. 23–73)	\$ 6,750,000
b) Statewide Historical Programs (pgs. 75–82)	\$ 7,750,000
c) Statewide History Partnership Projects (pgs. 83–89)	\$ 4,000,000
d) Exhibit on Minnesota’s Regions and Cultures (pg. 91)	\$ 2,500,000
e) Statewide Survey of Historical and Archaeological Sites (pg. 92)	\$ 500,000
f) Minnesota Digital Library (pg. 93)	\$ 500,000

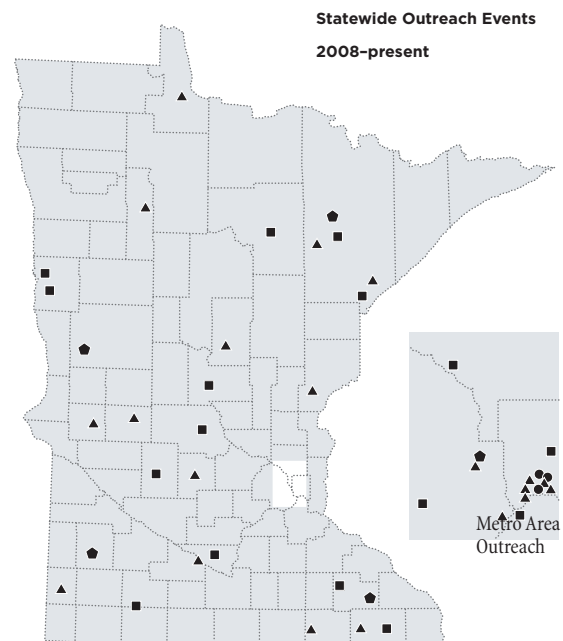
### Statewide Outreach

In late 2008, the Minnesota Historical Society began collaborating with the public and other history organizations to maximize the efficiency and effectiveness of funding historical projects from the Arts and Cultural Heritage Fund.

The Society worked to ensure that ACHF projects and programs benefit Minnesotans through at least one of the following ways: education, economic development, preservation.

To date, 44 gatherings involving 1,700 citizens have been held around the state (see map):

- ▲ Grants Workshops: Helped potential grantees apply for funding through the ACHF Historical and Cultural Heritage Grants Program.
- Historic Resources Advisory Committee: As required by law, the Society appointed a volunteer citizen panel to guide decisions for the Historical and Cultural Heritage Grants Program. These recommendations were then reviewed and approved by the Society’s governing board.
- Outreach Activities: Solicited opinions and ideas from citizens around the state regarding history expenditures and where funding is needed most.
- ◆ Ten- and 25-year Planning: The Society collaborated with a dozen other historical and cultural organizations to create a 10-year plan and 25-year framework for the use of ACHF funding.

**Accountability**

The 2009 legislature required that every project and program supported by the Arts and Cultural Heritage Fund “must include measurable outcomes, and a plan for measuring and evaluating the results.”

To meet this requirement, the Minnesota Historical Society is working with Wilder Research and the University of Minnesota Extension Center for Community Vitality to measure the economic value and outcomes of this biennium’s ACHF investments.

In May 2010, the Society began its efforts to ensure measurable outcomes were in place for all projects with a preliminary assessment by WJS Consulting. This led to the October 2010 awarding of a contract to Wilder Research. Wilder Research is assessing the Society’s current evaluation efforts and will assist staff in integrating this outcome-based requirement into their ongoing ACHF work.

In October 2010, the Society also began a project with the University of Minnesota Extension Center for Community Vitality to prepare an Economic Footprint of History Expenditures from the ACHF. While results are preliminary at this point, it is estimated that for every \$1 invested into history and cultural heritage, an additional \$1.95 was put back into the state and local economies.

Over the course of 2011, the Society will continue to evaluate the impact of its ACHF projects and programs ensuring that the programs are demonstrating measurable outcomes as well as economic value for citizens.

**Transparency**

The Minnesota Historical Society believes that it has a responsibility to the citizens of Minnesota to ensure that the dollars entrusted to our care are invested in ways that are transparent and will produce the greatest measurable impact on lives, enabling our state to thrive.

To meet this goal, the Society has assisted in the building of, and has itself built, web sites that inform the public about all ACHF initiatives funded through the Society. The first, [www.legacy.leg.mn](http://www.legacy.leg.mn), was created by the Legislative Coordinating Commission and contains information on all legacy-funded projects. The second web site, [www.mnhs.org/legacy](http://www.mnhs.org/legacy), is maintained by the Society and provides more in-depth project descriptions, media and information on opportunities to participate in history-related ACHF initiatives.

Through the end of the biennium, the Society will continue to post the most current information about the history-related ACHF initiatives on both web sites, ensuring transparency and responsible stewardship of the funds.

# Inspiring Students and Teachers

## “Our Minnesota”— A Cutting-Edge Exhibit for Tech-Savvy Students

When students step into “Our Minnesota” in late 2012, they will enter an exhibit like no other ever created. Our state’s rich history will spring to life while students, for the first time, will experience a 21st-century field trip designed just for them.

“I think it’s going to revolutionize the field trip,” said Wendy Jones, Head of Museum and Education Programs at the Minnesota History Center.

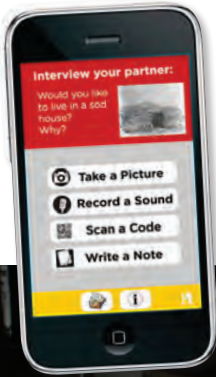
Instead of being told to put away their handheld technology, students will use it as an integral part of the exhibit. Exhibit developers are

now researching the best way for students to use a tool like a smart phone or an iPad to enhance the “Our Minnesota” experience.

Technology will also allow teachers to use elements of the exhibit before the field trip begins and after it ends.

“We’re taking this step not just because it’s cool, but to take the best of what technology has to offer, so we can really promote learning for students,” said Kate Roberts, Senior Exhibit Developer at the Minnesota History Center.

With \$2.5 million from the Arts and Cultural Heritage Fund, the Minnesota History Center is creating “Our Min-

Minneapolis. At stops along the way, streetcar windows will open onto various historical scenes. At University and Marion, the sound of a Tommy gun will introduce the story of a Dillinger gang member gunned down by St. Paul Police at that intersection in 1934.

“Our Minnesota” supports the state history standards and complements what students are learning in *Northern Lights*, Minnesota’s history textbook.

Students who visit “Our Minnesota” will begin their field trip long before they set foot inside the History Center. Exhibit staff are developing an online component students and teachers can use in the classroom to prepare for the exhibit. The mobile application being developed will allow students to download elements of “Our Minnesota” to bring home with them, extending the field trip long after it’s over.

“It’s about how kids today like to learn instead of trying to force them into a mold that no longer exists,” Jones said.

nesota” and also traveling exhibits to extend its reach to all corners of the state. The exhibit is being designed primarily for schoolchildren and incorporates the advice of dozens of teachers who participated in focus groups on the project.

While exhibits are always created with students in mind, Roberts said “Our Minnesota” will capture the attention of this new generation, which learns in a whole new way.

Today’s schoolchildren have been dubbed “digital natives.” They have grown up using the internet, video games and cell phones. They prefer to learn in a social, collaborative way that encourages them to ask questions and think critically.

“How do today’s students think, how do they process information, how do they use the tools provided to them?” Roberts said. “We are so completely focused on that student audience.”

“Our Minnesota” visitors will travel to three distinct areas of our state.

### *The Prairie*

In 1873, newlyweds Gro and Ole Rollag left Norway for a new life in Rock County, MN. A replica of a sod house in “Our Minnesota” is based on their home. Visitors will imagine a pioneer family huddling in the 12x16 foot space for an entire winter. Inside a full-scale tipi, visitors will encounter multimedia magic. Poet Bobby Wilson will deliver Dakota history in an engaging slam-poetry style.

### *The Forests*

Visitors will step into the shoes of a miner in the early 1900s. They’ll descend into an Iron Range mine, don headlamps and search for veins of ore. They’ll walk a path of stepping stones across the Mississippi River. They’ll become clerks and American Indians inside a fur post, each bartering for the best deal.

### *The Cities*

The story of the Twin Cities will be told aboard a streetcar “traveling” from the Capitol to downtown

## Reaching More Students: Interactive Video Conferencing

One day in the spring of 2010, Karleen Black's sixth grade classroom became a logging camp.

"The kids got up and became the different roles: loggers, crew leader, cook, tree," said Black, a teacher at Ogilvie Elementary.

Using video conferencing equipment, Black's class connected with a "lumberjack" back at the History Center in St. Paul who led them through a high-energy, in-depth lesson on this important chapter in Minnesota history.

"The students remember so much information because of the interaction," Black said. "All kids are engaged."

Interactive Video Conferencing (IVC) received \$496,427 from the Arts and Cultural Heritage Fund. The funds have been used to install an IVC studio at the History Center and to develop and deliver programs to more than 100 classrooms from Hinckley to Pipestone. Students experienced logging, Harriet Bishop's frontier schoolhouse and an expedition with Joseph Nicollet.

Almost every school district in the state has access to IVC equipment, allowing the History Center to engage students far beyond its building.

"It can actually take my students places where we can't afford to take them or to places that no longer exist," Black said.

## Supporting Teachers with More Training

Travis Smith teaches sixth grade in one of the most remote areas of Northern Minnesota. Grygla Elementary School is more than 300 miles from the Twin Cities.

“Without help with funding, there’s no way I’d be able to go down there,” Smith said.

But Smith did get help and it came from the Arts and Cultural Heritage Fund. In November 2010, he drove six hours to the Minnesota History Center in St. Paul to attend the Northern Lights Academy, a teacher workshop on Minnesota’s sixth grade history curriculum.

“I got to bounce back ideas with history teachers from around the state, share my ideas, and get ideas from them on what works best in the classroom,” Smith said.

\$228,046 from the ACHF is allowing more teachers like Smith to attend workshops and training programs that are held around the state.

The ACHF money reduces the registration fee from \$100 to \$50, provides subsidies for teachers who need them, covers substitute teacher fees up to \$100, mileage for teachers traveling more than 50 miles round-trip and lodging for teachers traveling more than 200 miles round-trip.



Over the past two school years, ACHF support defrayed training costs for almost 600 teachers. Doug Tinaglia, a sixth grade teacher at Faribault Middle School, also attended the Northern Lights Academy in St. Paul last November.

Ultimately, he said, it’s the students who benefit from more teacher training.

“Meeting with other teachers, finding out what works, it energizes me,” Tinaglia said. “That transfers to the students and their learning is greatly improved.”

## Legacy Field Trip Support Fund

# Investing in People and Communities

## Historic Library to Become 21st-Century Jobs Center

When Minneapolis Police Chief Tim Dolan's mother needed a break from her four spirited young boys, she would often send them to the North Branch Library near their North Minneapolis home. She knew how to make sure they actually made it there.

"We had to bring back proof," Dolan said.

One time Dolan brought back Homer's *Odyssey*. A librarian had suggested he read it. He did and he loved it.

"This library was a very special thing for us," Dolan told community members in the fall of 2009.

It has been decades since the old North Branch Library served the community like it did when Dolan was a boy. The community eventually outgrew the library, located near West Broadway, and it closed in 1977. The rare Chateausque-style building, built in 1893, retains its historical significance and is listed in the National Register of Historic Places.

Today, a non-profit called Emerge Community Development envisions new life for the oldest public library building in the Twin Cities. With help from a \$150,000 grant from the Arts and Cultural Heritage Fund, Emerge is creating a Career and Technology Center where people of all ages will have much-needed computer access and training.

"(The Center) will bring jobs to an area where they are greatly needed, create pathways into technology careers of the 21st-century and revitalize an impor-



tant historic landmark," said Lance Knuckles, Emerge's Director of Community Strategies.

Emerge staff say the Career and Technology Center will bring substantial economic benefits to the neighborhood. A study funded by the city of Minneapolis found that 45 percent of households in North Minneapolis have no computer access at home while almost 70 percent of jobs require technical skills. Staff predict the center will provide more than 1,000 neighborhood residents with computer access and training every year.

Emerge also projects that the Career and Technology Center will help place more than 300 clients in jobs in its first 10 years in operation.

The ACHF grant is funding an architectural assessment of the building and development of a design for the building's renovation.

Meanwhile, Emerge has raised almost 70 percent of its \$4.4 million goal and expects to begin construction on the old North Branch Library in early 2011.

"(The center) will serve as a catalyst for further revitalization efforts along North Minneapolis' most important commercial corridor," Knuckles said.

Knuckles predicts the old library's new mission will have a profound social and economic impact in North Minneapolis, an area hit hard by the recession and an area where staff say greater access to technology is imperative.

"I'm glad to see this grand old building will again be something useful for the community," Dolan said.

## Investing in Historic Downtowns

A handful of historic Minnesota communities just got a boost: the Minnesota Main Street Program is back in business, thanks to \$199,658 from the Arts and Cultural Heritage Fund.

Minnesota Main Street is an offshoot of the national Main Street Program, a proven economic development program designed to breathe new life into historic downtowns while preserving their treasures. Minnesota Main Street is already helping Brainerd, Faribault, Red Wing and Willmar with training and technical assistance so they can attract new jobs and businesses.

"It's helping us focus on priorities that deliver the greatest economic success," said Lisa Paxton, CEO of the Brainerd Lakes Chamber of Commerce.

Emily Northey, Minnesota Main Street Program Coordinator, said more communities are interested in joining the revitalization program now that more help is available to them.

"They're more likely to take the plunge when they know there's a support network," Northey said.

## History Helping to Create Community Leaders

Mai Xiong was just one year old when she came to the United States from Thailand. While growing up in St. Paul, she learned little about the Dayton's Bluff neighborhood where she lives or the experiences of other immigrants in her adopted city.

Xiong, now 22, is seeing St. Paul with new eyes.

"To know where you're living, what happened there, to learn about my culture and somebody else's culture. It's amazing," Xiong said.

Xiong is part of the Amherst H. Wilder Foundation's Neighborhood Leadership Program (NLP). During this six-month training program, participants build leadership skills and learn how to get more involved in their communities. More than 600 St. Paul residents from diverse backgrounds have completed the program in the past 15 years.

Last year, NLP added a new di-

mension. For the first time, the Wilder Foundation teamed up with the Minnesota Historical Society to give NLP participants a deeper knowledge of the communities they hope to improve and a better understanding of the context within which they are working. Topics ranging from the history of St. Paul to recent immigration stories are being integrated into each session of the program.

The partnership was paid for with \$109,725 from the Arts and Cultural Heritage Fund.

The ACHF support allows NLP participants to take part in the program, which kicked off last fall at the Minnesota History Center. Thirty-four participants and their 34 coaches experienced the exhibits and learned about the wealth of resources available through the Society.

"If I'm going to be working to improve



my community, it's important to know what has come and gone," said NLP participant Sherry Johnson of St. Paul.

Many were struck by the "Open House" exhibit, which tracks the dozens of different immigrant families who have lived in one St. Paul house from the late 1800s to today.

While Xiong has just begun learning about her community's past, she's already eager to return to the History Center and share the experience with her family.

"I'm going to bring my kids," she said.

# Dakota and Ojibwe: Preserving a Legacy

## Arts and Cultural Heritage Funds Help Secure Stunning Historical Discovery

A hump in the ground, with rocks sticking out of it, wouldn't catch most people's attention. But for archaeologist Grant Goltz, that hump led to the most stunning find of his 25-year career.

In September of 2007, Goltz and archaeologist Dr. Christy Hohman-Caine were performing a routine assessment of 47 acres of land on the north end of Leech Lake. A developer had plans to build a marina and upscale vacation homes on the Ottertail Peninsula site.

Then Goltz and Hohman-Caine spotted the hump.

"Finally, we said to each other, do you see what I see?" Goltz said.

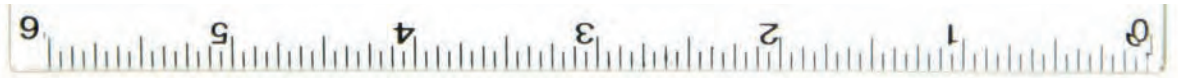
They investigated and eventually uncovered the remains of a fireplace from a fur trader's cabin, dating back to the early 1800s. The stone base was just as it was when the fireplace was first built.

"The ashes were still in it," Goltz said.

With further investigation, Goltz and Hohman-Caine







unearthed a fur trading ax, muskrat spears and a northwest trade gun that was still loaded. But those findings were just the beginning.

Under the ground where Goltz and Caine stood was a world lost through

time. Not only had there been a fur trading post on these wooded acres, but also a 1770s Ojibwe village that was central to the migration history of the Ojibwe people. Goltz also suspects there are burial grounds on the site.

“My eyes welled up with tears,” Gina Lemon recalled how she reacted when she first heard about the discovery.

Lemon’s father is a member of the Leech Lake Band of Ojibwe. She is the

tribe’s Historic Preservation Officer. She grew up hearing stories about sacred birch bark scrolls that document the westward migration of the Ojibwe into the Leech Lake area.

Historians now believe those scrolls depict the Ottetail Peninsula site as the western end of the Ojibwe people’s migration from the Atlantic coast.

“That’s our legacy, our missing link we never knew existed,” Lemon said. “We’ve seen it (in the scrolls), heard about it, but never put it together until now.”

Today, the Leech Lake Band of

Ojibwe and the Trust for Public Land are raising more than \$2.6 million to buy the property. The partnership has been awarded a competitive grant of \$679,710 from the Arts and Cultural Heritage Fund that will match other non-state funds being raised to protect this important resource.

“Now we have a legacy to hand down to our children,” Lemon said.

In a report about the site, Goltz and

Hohman-Caine write that at different points in the early 1830s, ethnologist and explorer Henry Schoolcraft and explorer Joseph Nicollet met with Chief Flat Mouth and the Leech Lake Ojibwe people on or near the site.

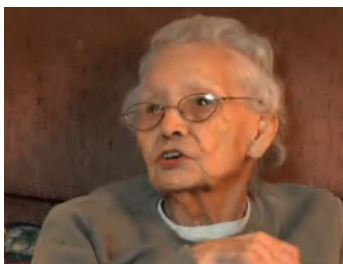
David Mather, the Society’s National Register Archaeologist, considers the site to be one of the most important unprotected historical sites in Minnesota. He is working with the Leech Lake Heritage Sites Program to get the site listed in the National Register of Historic Places. Mather also predicts the site may one day become a National Historic Landmark, which is a higher level of recognition.

Goltz said he has a hard time articulating the magnitude of what he stumbled across, easily the most memorable discovery of his career.

“The history still out there in the ground is unreal,” Goltz said. “You get goose bumps up your back just walking out there.”

## Preserving a Diminishing Resource: Dakota Wicohan Oral History Project



Until her death last year, 97-year-old Genevieve LaBatte of Granite Falls was the oldest person in Minnesota to speak Dakota as a first language.

Today, there are just eight first-language Dakota speakers left in the state.

Before LaBatte died, she shared her first language, stories from her life and her thoughts for the future with the Dakota Wicohan Oral History Project. The project received a \$50,000 ACHF grant through the Minnesota Historical Society.

“We can learn language from books, but when we have a speaker who grew up in the language, it means much more,” said Teresa Peterson,

LaBatte’s granddaughter and the project’s director.

Not only is the language being preserved, but also the Dakota history and culture transmitted through the language. Peterson is grateful to have oral histories from her grandmother and several other first language Dakota speakers to share with future generations. As those elders age, the window of opportunity closes.

“It’s really precious,” Peterson said.

## An Endangered Language Comes to Life Online

If you toss aside your idea of a traditional dictionary, and instead envision a multi-layered, multi-dimensional, online collection of Ojibwe language, culture, documents and artifacts, then you have imagined the Ojibwe People’s Dictionary.

“We are bringing together more than just a dictionary,” said Ojibwe History Specialist Brenda Child.

Users of the Ojibwe People’s Dictionary will be able to click on a word or sentence and hear them spoken by Ojibwe elders. Entries in the dictionary will be linked to images, sound and text resources on Ojibwe culture.

“The whole crux of the project is listening to voices. They give it life,” said Project Head John Nichols.

Nearly all fluent speakers of Ojibwe are over 65. The Ojibwe People’s Dictionary is designed to preserve and revitalize the language and also make Ojibwe cultural resources more accessible.

The Minnesota Historical Society and the University of Minnesota have partnered to create the dictionary with \$479,481 from the Arts and Cultural Heritage Fund. They envision it as an invaluable tool not only for speakers and students of the language, scholars and researchers, but for anybody who can log on to the internet.

“It’s free and accessible to everybody,” Child said.

## Legacy Beneath the Land: Statewide Surveys

It's been well over a century since explorers mapped out the land now known as Minnesota. What hasn't been sketched yet is a complete picture of what lies beneath our land.

"The view we have right now of the first 10,000 years of human history in Minnesota is like looking through a keyhole and trying to see the whole room," said Pat Emerson, Head of Archaeology for the Minnesota Historical Society. "We're just seeing a little bit of it."

With \$500,000 in Arts and Cultural Heritage funds, that is beginning to change. The ACHF is funding surveys of sites around the state that are historically, archaeologically and culturally significant.

"It's allowing us to open the door a little bit," Emerson said.

It's opening the door on areas like Swift County and the upper Minnesota River Valley.

"We know so little about ancient times there," said Dr. Michael Michlovic, Archaeology Professor at Minnesota State University Moorhead (MSUM).

Michlovic and his team were awarded almost \$69,000 to conduct an ar-

chaeological survey of Swift County. Before the survey began, Michlovic said it was hard to talk about ancient times in that area. Only about a dozen archaeological sites in the county had ever been identified.

Over the spring and summer of 2010, Michlovic and his team discovered over 40 more.

The team got permission from local farmers to comb plowed fields for artifacts. They focused on land near lakes and rivers. They found ancient shards of pottery and also spear points and arrowheads dating back 3,000 to 5,000 years.

"This is about the only way we can reach

back to the past and learn something,” Michlovic said.

Michlovic’s team included 10 undergraduate students from MSUM; students who gained practical skills and valuable work experience during the survey.

“The students had a great time and they learned so much,” Michlovic said.

The survey team now believes that the people who lived on or near those Swift County farms thousands of years ago may have been an isolated group. The team did not turn up evidence of much outside influence or materials that would have come from other places.

That knowledge has opened the door a little wider for Minnesotans who want to know who was here before us. The survey’s findings will be presented in an exhibit at the Swift County Historical Museum in Benson.

But there is much more to learn. And today’s explorers are eager to continue.

“The longer we leave the archaeological record unrecorded, the more likely it will be destroyed,” Michlovic said. “Archaeological sites don’t last forever. Learn it or lose it.”

## Survivors' Stories Shared and Saved

"I had never talked with someone who had endured so much tragedy and terror," explained Malcolm Kelner, a high school senior from Hopkins. "It really was a life-changing experience."

Kelner is talking about his friend Joe Rozenberg of St. Louis Park. When Rozenberg was 14, Nazis invaded his hometown in Poland. Rozenberg was forced into Auschwitz and two other concentration camps, where he

watched as his father was sent to the gas chamber.

Rozenberg lost every member of his family except one sister.

"To be in that situation, at that age," Kelner said, "how he got through that experience is unbelievable to me."

Kelner got to know Rozenberg and learn the wrenching details of his life while recording Rozenberg's oral history through a class at Talmud Torah of Minneapolis.

A \$7,000 grant from the Arts and Cultural Heritage Fund is allowing ten more students to connect with Minnesota Holocaust survivors before it is too late. Students will create an online video archive of survivors' stories before, during and after WWII, including their experiences settling and raising families in Minnesota.

"The students are learning life lessons," said Talmud Torah Executive Director Susie Chalom. "There is hope. You can rebuild your life even after the most devastating thing."

In 2045, long after all Holocaust survivors are gone, Kelner and his fellow oral historians from Talmud Torah will meet at the Holocaust Museum in Washington, D.C. Inside, 100 years after the liberation of Auschwitz, they will share their survivors' stories.

"It's up to the people who did learn their stories to pass them on to the next generation and beyond," Kelner said. "Their stories must be kept alive so something as horrible as the Holocaust can never happen again."

## Kids and Seniors: Connecting and Creating a Legacy

From Grand Rapids to Little Falls, from St. Paul to Spring Valley, Minnesota's youngest and oldest citizens are forging new connections made possible by the Arts and Cultural Heritage Fund.

With \$609,229 in ACHF support, the Minnesota Historical Society has hosted 12 intergenerational projects around the state. The projects allow kids and seniors to get to know each other while learning their community's history and practicing new skills together.

In Warroad, pre-teen girls gathered with women from the Warroad Senior Living Center to design and display four quilts inspired by life in the 1930s and 1940s.

One senior described her favorite part of the project:

"Meeting and interacting with the young girls. They were interested about the early years of Warroad and brought back many pleasant memories."

In Spring Valley, sixth graders and seniors worked together to create a picture book of city history for the community to enjoy.

A community member commented: "Very good [project]. I hope it expands to include more schools and students. I'm happy my tax dollars are being used for a [project] like this."

# Access for Everyone

## The Minnesota Digital Library

If today's historians do a good job preserving our historical resources and make them convenient to find and use, it will be that much easier for researchers, schoolchildren, teachers, genealogists and everyone else to draw on those resources in the future.

The Minnesota State Legislature has appropriated \$500,000 from the Arts and Cultural Heritage Fund to Minitex and the Minnesota Historical Society for a digital library project to preserve, digitize and share Minnesota images, documents and historic materials.

The Minnesota Digital Library (MDL) is administered by Minitex, an information and resource sharing program of the Minnesota Office of Higher Education and the University of Minnesota Libraries.

The funds are addressing several pressing needs.

### Preservation

One of those needs is finding an answer to this question: as technology changes, how can our digital collections be preserved for the long term, so that their quality is maintained for countless future generations?

Our history today is documented almost exclusively in digital form: we use digital cameras, digital camcorders, email and ebooks.

"If we don't have the means to preserve digital information, then there will be no information for anyone in the future to use for history books, History Day and other research," said Robert Horton, Minnesota Historical Society's director of Library, Publications and Collections.

The MDL is undertaking a major digital preservation initiative by participating in a prototype project with HathiTrust, a national shared digital repository. The MDL is exploring a way to ensure that the content from

its own *Minnesota Reflections* database and other institutions, including the University of Minnesota and the Minnesota Historical Society, will always be available to the public.

This pilot project will provide the MDL with the experience it needs to support the further development of preservation efforts to protect the state's digital heritage. Such experiences will allow the MDL to reach out to organizations in Minnesota that also have digital collections in need of long-term preservation.

### Newspapers Online

It's not something most people think about when they read the daily paper, but newspapers are actually daily history books, documenting noteworthy events within a community.

"Newspapers are the most important and the most popular resource we have in our library," Horton said. "They are used by every type of researcher for every type of research."

The Minnesota Digital Library is also developing a web site containing dozens of digitized newspapers from around the state making them accessible to everybody.

Horton says the Newspapers Online project saves time and money because content will be uploaded by just one

operation instead of dozens of individual newspapers. The newspapers are being digitized with funding from a variety of sources. In 2011, they will be online and available to the public on the MDL's website.

### Minnesota Reflections Web site

The Minnesota Digital Library's ACHF allocation is also making historical resources from around the state more accessible to students, teachers, researchers and the general public.

MDL's Minnesota Reflections web site contains a treasure trove of more than 58,000 historic photos and documents from more than 115 organizations across the state. Through the ACHF, resources continue to be added to the web site.

"There are lots of treasures in Minnesota we didn't know about. They've been hidden in boxes, in file cabinets and drawers," said MDL Outreach Coordinator Marian Rengel, whose position is supported by Arts and Cultural Heritage funds.

Rengel helps organizations across the state digitize their historical collections and upload them to the Minnesota Reflections web site.

## Excerpt of an Entry from Minnesota Reflections reflections.mndigital.org

"I remember my father coming home from Rochester one day in great excitement. The government had called on young men to enlist, and if they did not they would be shot down in their own dooryard. I can remember my mother crying and my father saying it was his duty to go."

~ Martha Dieter, recalling the day her father announced he was joining the Union Army.

Martha Dieter was a little girl living in a log house just north of Rochester when she learned her father was leaving to fight in the Civil War. After he left, Martha's family fought starvation, disease and bitter cold weather. Martha's gripping account of what her family endured during the 1860s in Southeastern Minnesota is just one of more than 58,000 historic documents and images that can be viewed for free by anyone with access to the internet through Minnesota Digital Library's *Minnesota Reflections* web site.

Martha, her mother and three siblings somehow managed to survive their dire circumstances. Martha's father did not. He became a prisoner of war and never saw his family again.

"...We heard that he had died when he was being moved from Andersonville to Libby Prison," Martha wrote, as an adult in 1936. "He was so nearly dead from starvation that he could not stand the trip. He was buried in a trench in the South."

## A Reliable Digital Resource: Encyclopedia of Minnesota History

Every day, Minnesotans search Wikipedia to get a question answered. If it's a question about Minnesota history, Wikipedia's answer may or may not be accurate.

"There's a need for a relevant, reliable resource related to Minnesota history," said Erica Hartmann, of the Minnesota Historical Society Press.

That need is being filled by the Encyclopedia of Minnesota History, a web

site being developed by the Minnesota Historical Society with \$265,576 from the Arts and Cultural Heritage Fund.

Encyclopedia entries will draw on the vast resources of the Minnesota Historical Society and its collections, images, library reference materials and more. The website is under construction with a launch in 2012.

Hartmann, the encyclopedia's editor, says it will be designed to be used

by a wide range of people: teachers, students, parents, journalists, tourists, researchers.

"It gets our resources out there to people who can't come here," Hartmann said.

## Traveling Exhibits: A Priceless Opportunity

Never had the Wright County Historical Society gotten such a great response from visitors.

"I can't tell you how many new members I picked up," said Business Manager Sally Stevens.

In a little more than a month during the summer of 2010, a traveling exhibit called "Journey Stories" attracted more than 1,200 visitors to the Wright County Historical Society. In the same time period the year before, the Wright County Historical Society saw just 65 people.

"In a rural county like Wright County, the money spent is priceless to us," Stevens said. "People traveled from all over—people who can't make it to the Smithsonian."

The traveling exhibit, part of the Smithsonian's Museum on Main Street program, was made possible by a partnership between the Minnesota Historical Society and the Minnesota Humanities Center. The partnership is supported by \$52,080 from the Arts and Cultural Heritage Fund.

In 2010-2011, "Journey Stories" is traveling from Winona to Thief River Falls and four other Minnesota communities in between. Another Museum on Main Street exhibit, "New Harmonies," will travel from Austin to Roseau and four other communities in 2011.



Another \$476,012 from the ACHF is allowing the Minnesota Historical Society to expand its own traveling exhibits with a program called "Exhibits to Go."

"The Legacy money is allowing us to reach more people with important stories of their history," said Aaron Novodvorsky, a Project Specialist at the Society.

Exhibits on Minnesota's maps, rural electrification, New Deal-era architecture, Minnesota disasters, the history of the Minnesota home front during World War II and other subjects will travel to communities throughout the state in 2011.

# Arts and Cultural Heritage Fund

## History Appropriations Language

**Session Law Reference:**  
**Laws of Minnesota, 2009,**  
**Chapter 172, Article 4,**  
**Section 2.**

(a) The appropriations in this subdivision are to the Minnesota Historical Society from the arts and cultural heritage fund to preserve and enhance access to Minnesota's history and its cultural and historical resources. Grants agreements entered into by the Minnesota Historical Society and other recipients of appropriations in this section shall ensure that these funds are used to supplement and not substitute for traditional sources of funding. Funds directly appropriated to the Minnesota Historical Society shall be used to supplement, and not substitute for, traditional sources of funding. Funds appropriated in the first year may be carried over to the second. No more than 2.5 percent of each appropriation may be used for administration by the Minnesota Historical Society. The Minnesota Historical Society, with the assistance of recipients funded under this section, shall report on all expenditures made from these funds to the legislature and governor by January 15 of each year.

(b) Statewide Historic and Cultural Grants. (i) \$2,250,000 in 2010 and \$4,500,000 in 2011 are appropriated for history

programs and projects operated or conducted by or through local, county, regional or other historical or cultural organizations; or for activities to preserve significant historic and cultural resources. Funds are to be distributed through a competitive grants process. The Minnesota Historical Society shall administer these funds using established grants mechanisms, and with assistance from the advisory committee created herein. The Preston grain elevator restoration and recreation project shall be eligible for grants under this program. Also eligible for a grant under this section are projects previously approved by the Minnesota Historical Society that have had this approved funding refused by a public board or governing body, provided that these projects are now administered by a nonprofit organization. Ironworld is eligible for a grant under this program. (ii) The Minnesota Historical Society shall appoint a historic resources advisory committee, with balanced statewide membership and representatives of local, county, and statewide historical and cultural organizations and programs, to provide policy and grant making guidance on expenditures of

funds from this paragraph. This membership shall include, but is not limited to, members representing the interests of historic preservation, local history, archaeology, archival programs, and other cultural programs related to the history of Minnesota. This committee shall seek input from all interested parties, and shall make recommendations for expenditures from these funds to the executive council of the Minnesota Historical Society; all expenditures must meet the requirements of Minnesota Statutes, section 138.01.

(c) Programs. \$3,000,000 in 2010 and \$4,750,000 in 2011 are for programs and purposes related to the historical and cultural heritage of the state of Minnesota, conducted by the Minnesota Historical Society.

(d) History Partnerships. \$1,250,000 in 2010 and \$2,750,000 in 2011 are for partnerships between and with the Minnesota Historical Society and partnering organizations to enhance access to Minnesota's history and cultural heritage in all regions of the state.

(e) \$2,500,000 in 2010 is appropriated to the Min-

nesota Historical Society for an exhibit on the regional, local, and cultural diversity of Minnesota's history and cultural heritage. These funds are available until expended. These funds are for the creation of both traveling exhibits to be made available to local historical and cultural organizations and an exhibit to be housed at the Minnesota History Center. The Minnesota Historical Society shall raise funds from private sources to augment this appropriation, with a goal of \$1,500,000 in private funds to be raised. This is not a match requirement, but the Minnesota Historical Society shall certify that a good faith effort has been made.

(f) Statewide Survey of Historical and Archaeological Sites. \$250,000 in 2010 and \$250,000 in 2011 are appropriated to the Minnesota Historical Society for a contract or contracts to be let on a competitive basis to conduct a general statewide survey of Minnesota's sites of historical, archaeological, and cultural signifi-

cance. Results of this survey must be published in a searchable form, available to the public on a cost-free basis. The Minnesota Historical Society, the Office of the State Archaeologist, and the Board of Indian Affairs shall each appoint a representative to an oversight board, to select a contractor and direct the conduct of this survey. The oversight board shall consult with the Minnesota Departments of Transportation and Natural Resources. Funds appropriated for this purpose do not cancel and may be carried over from one year to the next.

(g) Digital Library. \$500,000 in 2010 is appropriated for a digital library project to preserve, digitize, and share Minnesota images, documents, and historic materials. The Minnesota Historical Society shall cooperate with the Minnetex system and shall jointly share this appropriation for these purposes.



# Full Report of ACHF History Grants, Programs, Partnerships and Statewide Initiatives

Since the passage of the Legacy Amendment on November 4, 2008, the Minnesota Historical Society has carefully used funds to develop exhibits, fund educational programs, form partnerships and award grants that will help Minnesotans understand their past, and in turn, move on to a better future. The next tabbed sections of the report are organized to reflect the six sections of the appropriations bill and funded initiatives in each area.

With these initiatives, programs and grants, Minnesotans across the state have an unprecedented ability to preserve their history for many years to come and to provide a true legacy gift to future generations. # Historical and Cultural Heritage Grants Program

Minnesota is fortunate to have more than 500 active historical organizations across the state, ranging from county and local historical organizations to topical historical organizations, such as transportation history museums, to organizations that preserve historic structures. Each of these organizations serves an important role in preserving significant stories of the people and events of Minnesota. Through the Minnesota Historical and Cultural Heritage Grants Program, the Minnesota Historical Society, with the assistance of the Historic Resources Advisory Committee (a citizen advisory panel), awarded 474 grants, totaling \$6.55 million, through a competitive process to 343 organizations in 86 Minnesota counties. Despite the tremendous success of this program, the need for Historical and Cultural Heritage Grants is great and demand outweighed available resources by a ratio of six to one.

The following 50 pages list all of the grants awarded through this program.

The Minnesota Historical Society presents award-winning exhibits and educational programs that share Minnesota stories with Minnesotans of all ages. With support from the Arts and Cultural Heritage Fund, the Society has created more than 40 statewide historic programs to reach new audiences using interactive technology and innovative training methods, as well as to preserve Minnesota's historical and cultural heritage. In fiscal years 2010 and 2011, the Society has invested \$7.75 million in these programs, which have reached all corners of the state.

## Inspiring Students and Teachers

Bringing Minnesota history to life and into the classroom in more impactful ways.



### Innovative Training Opportunities for Minnesota's Teachers

**\$228,046**

In 2009 and 2010, more than 565 Minnesota teachers benefitted from professional development workshops led by the Minnesota Historical Society. These innovative training opportunities included a Northern Lights Academy program at the Minnesota History Center, immersion programs at historic sites, partnerships with social studies organizations and professional development programs for teachers in rural school districts. In the first seven months of 2011, seven additional education workshops are planned, including a two-day social studies bus tour to various historic locations around Minnesota. ### Interactive Video Conferencing

**\$496,427**

The Minnesota Historical Society launched a pilot program to provide interactive educational programs for fourth through sixth grade students, using new video-conferencing capabilities. Three programs, including one featuring Harriet Bishop, the first schoolteacher in St. Paul, allow students to stay in their classroom while role playing, interacting in real-time with historical characters and participating in related activities. The test programs, which were piloted in schools in six counties throughout Minnesota, reached 1,200 students in the spring of 2010. More than 100 teachers participated in the prototyping process and provided valuable feedback. These programs are now being expanded and reservations can be booked in classrooms across Minnesota. Two additional video conferencing programs, one targeted at high school students and one for lower elementary students, are also in development and scheduled for launch in 2011. ## Creating Success for 21st-Century Learners

\$315,834

Today's students have grown up with technology. Research shows that traditional teaching tools, such as textbooks and lectures, don't fully engage these "digital natives" for whom technology has always been at the center of their lives. As teachers strive to reinvent their classrooms to meet the needs of this new generation, the Minnesota Historical Society is using ACHF funding to conduct research and to develop programs and materials that will support teachers' classroom needs and engage digital natives in the study of history. Extensive focus groups with educators, parents and students throughout the state yielded two seminal reports that are guiding the current development of new field trip experiences at eight of the Society's historic sites and museums. These new programs will use technology to engage students in the exploration of history and will promote the development of 21st-century skills, including critical thinking, problem solving, creativity and innovation. Already organizations across the country are planning to leverage this research, which may form the basis for a national model.

## Legacy Field Trip Support Fund

\$109,345

Affordable transportation is one of the biggest barriers for schools' ability to plan field trips to Minnesota Historical Society sites and museums. By June 2011, nearly 400 schools across Minnesota will access the Society's Legacy Field Trip Support Fund, which means more than 30,000 students will be able to learn about history through field trip experiences they otherwise might have missed. ## American Indian "Hands On" History Curriculum for Minnesota's Students

\$290,461



Recognizing the importance of hands-on learning, the Minnesota Historical Society developed new curriculum with a particular emphasis on American Indian history in Minnesota. One activity from this curriculum allows students to create an Ojibwe shoulder bag. In another activity, students create a winter count, a tool used by the Dakota to record key historical events. The Society offers complete kits for these learning projects that include all the resources a teacher needs to do the classroom activity. The kits also contain additional learning resources like a comprehensive teacher's guide, laminated classroom placards, instructional DVDs and a resource CD. Through projects like these, Minnesota students are being introduced to Ojibwe and Dakota culture, history and arts, as required by the Minnesota learning standards.

## History Day Expansion

\$381,622

History Day, an annual program co-sponsored by the Minnesota Historical Society and the University of Minnesota, challenges young people to research a historical subject related to an annual theme and present their findings in the form of exhibits, documentaries, performances, web sites and papers, much like a "science fair for history." ACHF funding made it possible for the Society to provide additional services to 118 schools in 39 counties across the state. Services included classroom visits by Society educators, support for field trips to county and university libraries, the assignment of mentors from MNSCU campuses to advise local students and organizing regional professional development workshops for History Day teachers. More than 150 teachers used these services, benefitting approximately 10,000 Minnesota students in grades six through 12.

## Online Fur Trade Interactive Experience

\$60,000

In 2010, the Minnesota Historical Society researched the development of an Online Fur Trade Interactive Learning Experience as a supplement to the Northern Lights history textbook. This web-based application, geared toward middle school students, will not only offer a glimpse of Minnesota's history, but also provides a lesson about the foundation of today's complex global economy. With additional funding, the Society will build and launch this program in 2011, eventually rolling it out nationwide to create exposure for Minnesota's North West Company Fur Post in Pine City.



## Mobile Learning Project

**\$97,437**

The Minnesota Historical Society is developing a mobile application that will allow students to investigate Minnesota history anywhere, any place and anytime, using their handheld mobile devices. In addition, the Society is designing a mobile technology component for the History Center's "Our Minnesota" exhibit that will enable students to immediately apply what they've learned in exhibits. This technology will allow students and teachers to "harvest" items from collections for use in the classroom and to take the exhibit experience home or back to their school.

## Engaging Students in Minnesota History through Internships and Education

**\$198,220**

Developing a passion for history often starts well before adulthood. To foster this interest, the Minnesota Historical Society has developed an internship program to serve both high school and college students during the 2010–2011 school year. The funding to date has supported the hiring of staff and the initial recruiting for this program. To enrich the internship experience, the Society is introducing additional discussions and classroom presentations for all college interns over a semester-long period. In addition, the Society plans to launch an educational summer program, in partnership with the University of Minnesota, directed at disadvantaged youth, focusing on skills that address the Minnesota State Learning Standards for History and Social Studies.

## Re-envisioning the Online Presence of Education

**\$57,050**

Recognizing the importance of reaching K-12 students, as well as their parents and teachers, much of the Minnesota Historical Society's web site is specifically aimed at these groups. While the existing web site, [www.mnhs.org/school](http://www.mnhs.org/school), is widely used, it has become unwieldy and difficult for the intended audiences to explore and engage with the Society's plethora of content and services. Through this project, the Society completed an evaluation of the site to determine student and teacher needs, how they currently use the site and how best to deliver online products. The evaluation resulted in a plan that will be used to redesign the site to make it more user-friendly, easier to navigate and focused on delivering enriched academic resources.

## Multimedia Support

**\$201,033**

Many projects and programs funded by the ACHF required multimedia support to generate online content, to create online training and video resources and to document programs. This funding helped deliver those services to ensure a seamless and positive experience for users accessing information and new digital content made possible by ACHF projects.

## Access to History for Everybody

Giving more Minnesotans access to historic sites, museums and programs.

## Expansion of Statewide History Players Program

**\$149,344**

The History Players program is a popular program in which actors portraying historical figures come to Minnesota classrooms to give students "real life" lessons in history. ACHF funding is enabling the Minnesota Historical Society to expand access to the History Player program. Starting in 2011, the cost to schools for the program will be significantly reduced and the Society will pay for the mileage and travel expenses for programs booked outside the Twin Cities metropolitan area. Scholarships are also now available to cover the full cost of the program for eligible schools and organizations. In addition, the Society is increasing accessibility by adapting the program for senior citizens and families, making History Players available to nursing homes and public libraries across the state.

## Digital Encyclopedia of Minnesota History

**\$265,576**

Increasingly, people are turning to digital resources for answers to questions or as a starting point for research. The Encyclopedia of Minnesota History will be a new digital resource for the public from the Minnesota Historical Society. It will provide reliable, multimedia entries about people, places, events and things in Minnesota history. The Society launched the project in 2010 and developed a comprehensive plan, including surveying more than 60 local and national experts and evaluating 40 comparable digital resources. In 2011, the project team will develop a prototype that will test initial entries and technology, invite user feedback, inspire content partnerships and guide full web site implementation in 2012. For more on this program, see page 19.

The Minnesota Historical Society created a new traveling exhibits program, called “Exhibits to Go,” giving more than 15 communities across Minnesota the ability to experience Minnesota history in their own neighborhood. Funding for the traveling exhibits came from multiple appropriation categories, including funding for Statewide Historic Programs and for History Partnership Projects. See page 87 for funds awarded to partner organizations to help make these exhibits possible. The traveling exhibits feature freestanding displays, audiovisual and interactive components, and onsite and online educational programming. To date, four exhibits—“Minnesota on the Map,” “Minnesota Homefront,” “Electrifying Minnesota” and “Uncle Sam’s New Deal”—are available through this program. In addition, the Society partnered with the Minnesota Humanities Center to bring exhibits from the Smithsonian Institution to Minnesota, as highlighted below:

- **“Minnesota on the Map”**

This exhibit features a dozen maps from the Minnesota Historical Society collections, from Louis Hennepin’s 1683 map of the upper Mississippi River Valley to a satellite map of Minnesota produced by NASA. The maps are reproduced on seven portable exhibit panels and a video station provides commentary on a selection of the maps. One highlight of the exhibit is an oversized jigsaw puzzle map of Minnesota that engages schoolchildren and other young visitors.

- **“Minnesota Homefront, World War II”**

Change came quickly after the bombing of Pearl Harbor. Featuring nine panels, audio interviews, songs of the period and a “Letter Stories” bin, this traveling exhibit shares the experiences of 46 Minnesotans and the state’s role in the most widespread war in history. Visitors to this exhibit can discover what it was like to “make do” with rationing, farm during a severe labor shortage and endure a starvation experiment for science and the war effort.

- **“Uncle Sam’s New Deal”**

Partner Organization: Minnesota Landmark Center

With recent headlines about stimulus packages and infrastructure issues fresh in the minds of citizens, “Uncle Sam’s New Deal” illuminates the Federal government’s role in efforts to revive Minnesota communities more than 70 years ago. ACHF funds enabled the Minnesota Historical Society, in partnership with the Minnesota Landmark Center, to prepare the exhibit for statewide touring. The exhibit, which is scheduled to travel to six communities in 2011, includes portable panels, New Deal film footage and an interactive art activity.

- **“Electrifying Minnesota”**

Partner Organization: Bakken Museum

Imagine having electricity available at the flick of a switch for the first time. “Electrifying Minnesota” explores how electricity has transformed lives in Minnesota since 1882, from what people thought about electricity in the late 19th and 20th centuries to how we will generate electricity in the 21st century. ACHF funds have enabled the Minnesota Historical Society, in partnership with the Bakken Museum, to take this exhibit on the road. Featuring portable exhibit panels, period silent films and an interactive electromagnetic generator, the exhibit will travel to five communities, inviting visitors to rediscover a sense of wonder about how electricity shapes our lives.

- **Smithsonian Museum on Main Street Exhibits**

Partner Organization: Minnesota Humanities Center

The Minnesota Historical Society, in partnership with the Minnesota Humanities Center, brought the Smithsonian Institution’s “Journey Stories” exhibit to Minnesota. This exhibit, which is part of the Smithsonian’s Museum on Main Street initiative, focuses



on tales of how immigrants came to America and also examines modes of travel and Americans’ desire to feel free to move. In a subsequent project, the Society and Humanities Center sponsored an open application process through which six Minnesota communities were selected to host the Smithsonian’s “New Harmonies: Celebrating American Roots Music” traveling exhibit. This exhibit will be the fifth of the Smithsonian’s Museum on Main Street exhibits to visit the state. It begins its Minnesota tour in March 2011. For more on this traveling exhibit, see page 20.

**\$609,229**

“Connecting Generations through History” launched in November 2009 with 12 projects statewide, facilitated by Minnesota Historical Society staff, historic sites and public libraries. The projects were designed to foster deep intergenerational learning, while preserving important community stories. Final events to mark the projects’ completion drew large crowds. Each project is featured on a new web site “Sharing Community Stories,” <http://legacy.mnhs.org/sharing-community-stories>, which launched in late 2010. In another aspect of intergenerational programming, the Society established a Teen Advisory Council. These teens work in partnership with History Center staff to hone their workplace skills as they develop teen-oriented programming for the History Center. Based on the Advisory Council’s work, the History Center produced the “Ready, Set, Music!” event in June 2010 and is planning an oral history-based theater program scheduled for spring 2011. ## E-book Publishing

**\$52,692**

The Minnesota Historical Society Press (MHS Press) converted more than 125 MHS Press/Borealis Books titles to digital formats for multiple e-book readers, including the Kindle, the Nook, the Sony E-reader and the Apple iPad, allowing us to meet the needs of not only young, tech-savvy readers, but also users in the over-50 age bracket who have been among the first adopters of e-reader technologies. MHS Press also developed its first “enhanced e-content” project with ACHF funds: a new mobile application to accompany the paperback book, *Dad’s Eye View of the Twin Cities*. This application allows for sharing among parents and other caregivers, encourages intergenerational connections and gives users a fun new way to explore important cultural and historical places in the Twin Cities.

## Digitization of Minnesota’s Newspapers

**\$209,102**

Working with the Minnesota Newspaper Association, local historical societies and newspaper publishers, the Minnesota Historical Society launched an innovative project to expand the number of contemporary newspapers available in digital form. In the pilot phase of the project, the Society developed a methodology for digitizing, preserving and indexing newspaper content. Those processes will be tested with six newspapers and optimized in 2011. With ACHF funding, the Society was also able to purchase necessary hardware and software to store the newspaper files and to make the content available to researchers through the Society’s reference library, as well as through a web site that will be available to the public.

## Digitization of Historical Collections

**\$338,579**

Through this funding, the Minnesota Historical Society is advancing the work of making collections information available online. The Society is photographing 3D objects in the collections and completing corresponding descriptions that will be published online, allowing web site visitors to access an increasing volume of historical information. With more than 250,000 objects in the 3D collections alone, the Society is prioritizing efforts on objects that document popular topics appealing to History Day students and the general public. Collections assistants are also scanning iconic Minnesota documents from the Society’s manuscript collections, linking these images to the online inventory of library resources and creating blog entries and podcasts to showcase rare and unusual examples from the collections.

## Public Awareness and Communication

**\$274,229**

The Minnesota Historical Society created communication strategies and promotional materials for many of the ACHF-funded programs to increase public awareness and ensure that citizens, educators and students would use and benefit from the new programs.

## **Investing in People and Communities**

Supporting local history organizations and historic site programs.

---

### **Support of Local History Organizations**

**\$465,345**

The Minnesota Historical Society launched a new program to expand services supporting the work of local history organizations, especially in relation to the Minnesota Historical and Cultural Heritage Grants Program. The Society sought out potential grant applicants, led grant-writing workshops, presented at 43 public meetings statewide and conducted onsite visits in approximately 40 communities. As a result of this work, more than 894 organizations submitted a grant application, resulting in 474 grants to organizations in 86 Minnesota counties.

---

### **Reaching Out to the Community through Historic Site Programs**

**\$154,272**

The Minnesota Historical Society manages 26 historic sites and museums across Minnesota. Recognizing an opportunity to work more collaboratively with organizations where historic sites are located, the Society developed programs to expand history education and programming and elevate the level of professionalism in local history organizations. This funding enabled site staff across the state to host workshops to train history professionals and work with local historical agencies to assess and update collections. For example, in Little Falls, a staff member from the Charles A. Lindbergh site helped the Minnesota Military Museum organize and catalog several important collections, including the Gen. John W. Vessey, Jr., collection and the M.G. Ellard Walsh collection, and assisted with the inventory and organization of the museum's weapons collection.

---

### **Sustainability of Programs and Facilities**

**\$125,000**

The Minnesota Historical Society recognizes the critical relationship between sustainability and historical preservation and the importance of environmental stewardship as we preserve our cultural heritage for future generations. For this reason, the Society is studying its level of sustainability, including levels of energy consumption, water usage, waste and resource use. As part of the comprehensive study, data is being collected for the Society's 26 sites and more than 100 historic buildings and modern facilities. The assessment is scheduled for completion in February of 2011, with time in the following months to establish goals and recommendations. The outcome of the study, due in June 2011, will be a report that includes the assessment, goals and strategies for the whole institution, as well as individual sites. This plan will also provide a framework for reducing its environmental impact. The final report will also serve as a lasting tool to continue monitoring progress toward sustainability and to evaluate strategies based on potential environmental impact reductions, cost and complexity.

---

### **Technology Enhancements**

**\$626,328**

With the approval of many ACHF projects and partnerships that include a component of enhanced online access to Minnesota Historical Society information and materials, the Society needed to increase the capacity of its technology platform. This funding enabled the Society to purchase servers and equipment to meet the increased demands created by the ACHF programs.

---

### **Legacy Volunteer Corps.**

**\$44,820**

Every year, more than 2,300 people volunteer in support of programs and projects delivered by the Minnesota Historical Society. With the addition of more than 100 ACHF-funded projects, the need for volunteers also increased. This funding enabled the Society to recruit, coordinate and supervise volunteers helping with Legacy projects. As of December 2010, nearly 80 new volunteers were recruited, trained and placed, including 10 percent from diverse communities. These volunteers have already donated nearly 900 hours to support new programs.

## Linking Past, Present and Future

Helping Minnesotans connect to their past, while preserving their future legacy



### Alexander Ramsey House Revitalization

**\$92,476**

The Alexander Ramsey House is an 11,000-square-foot mansion that was home to Minnesota's first territorial governor. The mansion contains approximately 14,000 original furnishings and has one of the most intact collections of Victorian-era artifacts in the Midwest. Despite these assets and a sound public educational program, the site has experienced a steady decline in attendance. ACHF funding is supporting a project to understand the reasons for this decline. The master plan that results from this study will create a new operational model to make the site relevant to 21st-century audiences. This plan will be used to revitalize the Alexander Ramsey House and will be shared with other historic houses across the state and nation.

### Great Rivers Network Portal

**\$130,000**

The Great Rivers Network portal, [www.greatriversnetwork.org](http://www.greatriversnetwork.org), promotes the development, discovery and use of historical collections held by the Minnesota Historical Society and its partners across Minnesota. Through this project, the Society provides support and training to organizations statewide for the preparation of digital collections data, while providing a technical infrastructure that enables access to various collection components, such as photographs, manuscripts, vital record indexes and library catalogs.

### Preserving Language and Culture through Stories— Jeffers Petroglyphs Site

**\$74,113**

Indigenous people have always used stories to preserve and teach culture to each succeeding generation. Through this project, the Minnesota Historical Society will collect, record and interpret stories specific to the Jeffers Petroglyphs site. The stories from tribal elders will be recorded and transcribed in their native language as well as in English, culminating in written interpretations that will be made available to a wide audience of scholars, students and the general public. This project will help preserve and teach indigenous language and culture to Minnesotans as a lasting legacy.

### U.S.-Dakota War of 1862 Sesquicentennial

**\$325,847**

In 2012, the Minnesota Historical Society will commemorate the U.S.-Dakota War of 1862 through a variety of programs and methods, including online presentations, educational tools, published works, artwork, events and community outreach. Online resources will present a collection of oral histories and modern perspectives on Dakota life from Dakota elders. In addition, the Minnesota Historical Society Press (MHS Press)/Borealis Books will acquire stories from the community and research from experts about the history and language of the Dakota, including materials on the war and events leading up to and following it. MHS Press will publish books, journal articles, teachers' guides, language workbooks and other resources to help citizens further understand the complex history of the Dakota in Minnesota.



## Fort Snelling Virtual Tour

\$436,634

The Minnesota Historical Society is collaborating with the Institute for Advanced Technology in the Humanities at the University of Virginia to build four computer models of Fort Snelling that will illustrate the Fort at various points in its history. These models are being incorporated into a web site that will feature map-based and time-specific access to information about the Fort, its history and its significance to Minnesota and American history. The models will be linked to a rich and interrelated set of materials from all parts of the Society's collections, including photographs and manuscripts. The result will be a web experience that will provide a unique educational experience to students as they explore the significance of a dynamic and changing Fort Snelling from 1820 to 1945.

## Restoration of Governors' Portraits

\$45,094

The portraits of Minnesota's governors grace the halls of the Minnesota State Capitol and provide an important legacy of the state's past and present leaders. With funding from the ACHF, 20 portraits were cleaned and are now more secure with the addition of high-quality non-glare/UV filtering plexiglass. Using the original framing, each portrait was retrofitted to accommodate the new plexiglass.

## Capacity to Support ACHF-Funded Projects

Developing the required capacity to support projects created by the Arts and Cultural Heritage Fund.

## 25-Year Framework and 10-Year Goals

\$14,719

The Minnesota Historical Society, the Minnesota State Arts Board and the Minnesota Humanities Center hosted a series of listening sessions and posted an online survey to obtain public input on how the ACHF funds should be spent. Using this input, a 13-member committee comprised of representatives from the three organizations and 10 other history, arts and cultural organizations and libraries worked together to develop a 10-year plan and 25-year framework for the use of ACHF funds. ## Administrative Expenses

\$425,689

In order to implement its ACHF projects, the Minnesota Historical Society hired an ACHF Program Coordinator to oversee the program administration. The Society also made investments to support administration of the grants program and to fund expanded financial management and administrative functions. By carefully managing its costs, the Society has adhered to the legislative mandate that institutions not spend more than 2.5 percent on administrative expenses.

## Program Evaluation

\$100,000

To fulfill the expectations of the legislature and the people of Minnesota, the Minnesota Historical Society has engaged Wilder Research and the University of Minnesota Extension Center for Community Vitality to assist in evaluating the outcomes and value of the Society's ACHF investments. This work is enabling the Society to effectively evaluate the outcomes of its ACHF-funded programs and partnerships.







# Statewide History Partnership Projects

To promote the sharing of knowledge and resources among historical organizations, Legacy legislation appropriated funding for projects carried out by history partnerships. During this biennium, this funding has resulted in partnerships between the Minnesota Historical Society and more than 20 other organizations, as well as 30 additional partnerships between other history-minded groups. These history partnerships are helping to extend the reach of the Arts and Cultural Heritage Fund across the state.

## Partnerships with the Minnesota Historical Society

### Asian-American Oral History Project

Partner Organization: Council of Asian Pacific Minnesotans

**\$120,000**

During the past 20 years, the Minnesota Historical Society has successfully worked with many immigrant communities in the state to ensure that the stories of their arrival, settlement and adjustment to life in Minnesota become part of our historical record. For this project, 25 oral history interviews were completed with leaders in each of five Asian communities in Minnesota: Cambodian, Korean, Lao, Philippino and Vietnamese. The interviews will be available on the Society's web site (<http://education.mnhs.org/immigration>), which features individuals who comment with authority on the community's composition, challenges, achievements and contribution to Minnesota's cultural landscape.

### Chicano-Latino Oral History Project

Partner Organization: Chicano Latino Affairs Council

**\$175,255**



The Latino population in Minnesota has grown dramatically since 1980, both in the Twin Cities and in Greater Minnesota, in cities such as Worthington, Willmar, St. James, Moorhead, Melrose, Long Prairie and Albert Lea. This project involves interviewing Chicano-Latino elders and community leaders from approximately a dozen Latino population centers in the state. The interviews will be available on the Society's web site (<http://education.mnhs.org/immigration>), providing a baseline for understanding the current composition of Latino populations, their successes and challenges and the evolution of their relations with the broader community. More than 30 interviews were completed and transcription, editing, photo scanning and related activities are underway.

## Geo-tagging Collections

Partner Organization: Minnesota Geospatial Information Office

**\$170,807**

In partnership with the Minnesota Geospatial Information Office, the Minnesota Historical Society is adding geographical markers to more than 120,000 of the Society's historic photographs. One outcome of this initiative will be the creation of a web experience that will allow students and the public to use "place" as a gateway for discovering other collections materials. This project will complement the Society's online photo collection and will be an access point for viewing other digital collections online.

## Minnesota Main Street Program

Partner Organizations: Preservation Alliance of Minnesota, Department of Employment and Economic Development, University of Minnesota Extension Center for Community Vitality

**\$199,658**



The Minnesota Main Street Program is a comprehensive strategy that helps Minnesota communities preserve historic buildings, while providing training, tools and support for commercial revitalization. ACHF funding has enabled the re-launch of this program. Since the official kick-off on May 1, 2010, four cities have been designated as Minnesota Main Street Communities—Brainerd, Faribault, Red Wing and Willmar—with another 12 registered as associate members. Passage of the state historic structure rehabilitation tax credit in April 2010 offers yet another valuable tool for communities to use as they strive to breathe new life into their historic downtowns. ## History Museum Fellows Program

Partner Organization: University of Minnesota Twin Cities

**\$191,138**

This program, sponsored by the Minnesota Historical Society and the University of Minnesota, provided 10 undergraduate college students with the opportunity to become History Museum Fellows in 2010. The program launched with a semester-long course at the University of Minnesota where the students were introduced to issues related to diversity and museums, followed by a paid summer internship at the Society. The Fellows chose from a wide range of internship positions and also interacted with professionals in the field during a museum study trip to Washington, D.C. The program engaged students in discussions about ways to address the underrepresentation of communities of color and American Indian nations in historical organizations and public history graduate programs. A second group of 12 to 15 Museum Fellows will begin in the spring semester of 2011.

## Library Outreach Programs

Partner Organizations: Minnesota Regional Library System

**\$217,825**

Through this partnership, the state's regional network of more than 370 public libraries is hosting a series of educational programs based on the Minnesota Historical Society's nationally acclaimed "Minnesota's Greatest Generation" exhibit and programs. Since the project launched in 2009, more than 200 programs have been sponsored in every regional library system across the state. For example,



the public library in Aurora held an event entitled, "Minnesota History Morning at the Library: Growing up in the 1930s," which was attended by homeschooled children and their parents. The Spring Grove Public Library hosted an event called the "Golden Age of Radio," in which Prudence Johnson and Dan Chouinard shared their interpretations of classic 1930s and 1940s standards in voice and piano. According to library staff, even the children were scrambling for autographs after the show. "This partnership enables us to provide library patrons access to engaging history programs that aren't available anywhere else in the country," said Mark Ranum, Director of the Plum Creek Library System, Worthington.

## Environmental History Study

Partner Organization: Macalester College

**\$16,750**

Through this partnership, students from Macalester College are conducting a study to identify, select and assess historic content related to Minnesota's environmental history, using archival, archaeological and geospatial data at the Minnesota Historical Society. The pilot project is a place-specific case study at the Katharine Ordway Natural History Study Area (KONHSA), located on the bluffs of the Mississippi River in Inver Grove Heights. The material derived from this research will be used in classrooms and at the KONSHA site, to help teach students about environmental history and about the use of historic primary sources in scientific study. One outcome of the pilot is a proposal for a Twin Cities Environmental History Conference with state experts and nationally renowned scientists and historians, setting the stage for a larger project to further explore the confluence of environmental science and Minnesota history.

## American Indian Summer Seminar

Partner Organizations: Minnesota Humanities Center and Tribal Colleges

**\$105,250**

The American Indian Summer Seminar offers a unique educational experience for American Indian students from across Minnesota. The 15 students selected to participate in this intensive three-week residential program will attend classroom presentations and experience hands-on learning about the museum field and other historical and cultural preservation organizations. The students will learn about various career paths and academic requirements for working in these types of organizations, both on and off reservations, as well as particular challenges faced by American Indian communities related to preserving tribal history.

## Building on the Legacy of Conservation Corps

Partner Organization: Conservation Corps of Minnesota

**\$74,525**



The legacy of the last original members of the Civilian Conservation Corps (CCC) in Minnesota is being passed on to today's young members of the Minnesota Conservation Corps (MCC) through interviews with CCC members. Subsequently, the members of the MCC are interpreting the early 1930s history of the Minnesota Forest Service (forerunner to the Minnesota Department of Natural Resources) and sharing the history of the CCC by leading educational programs at the Forest History Center. The MCC members are also conducting 1930s-era construction projects and teaching visitors to the Forest History Center about modern forest management and conservation practices through demonstrations on the Center's 150 acres of forest. CCC programming at Forest History Center, Grand Rapids.

## Neighborhood Leadership Program

Partner Organization: Amherst H. Wilder Foundation

**\$109,725**

The Minnesota Historical Society is partnering with the Amherst H. Wilder Foundation to continue the Neighborhood Leadership Program, an initiative that develops leadership skills of community members to take effective action. Through ACHF funding, the program agenda has been expanded to include sessions integrating historical resources, lessons and visits to the Minnesota History Center, providing participants with greater access and awareness of the Society's resources. Approximately 30 diverse community members from St. Paul participate in the six-month program each year. By participating in history-related programming and discussions hosted by the Society, participants learn about the diverse history of St. Paul and come away with a deeper understanding of their unique roles as they take action to improve their community. ## Expanding Access to American Indian Objects from the Bishop Whipple Collections

Partner Organization: Science Museum of Minnesota

**\$293,234**

The Science Museum of Minnesota and the Minnesota Historical Society each maintain important historical collections of American Indian cultural objects assembled by Bishop Henry Benjamin Whipple. The objects document the changes experienced by the Dakota and Ojibwe in Minnesota in the 19th century. ACHF funds are enabling the Society and Science Museum to fully research, catalog and digitally record the 500 objects in the Whipple collection. The two institutions are also collaborating on a web site that will enable wider audiences to interact with these images and learn stories about this important collection of artifacts.

## Minnesota Conservation Volunteer Magazine Digitization

Partner Organization: Minnesota Department of Natural Resources

**\$54,709**

Through a partnership with the Minnesota DNR, the Minnesota Historical Society is digitizing the full run of the DNR's Minnesota Conservation Volunteer magazine. When the project is completed in summer 2011, all issues of the publication dating back to 1940 — or 28,000 pages — will be available to the public online. Making these publications available online, complete with a searchable online index of the archive, will provide a picture of the gradual evolution of Minnesotans' interest in natural resources and outdoor recreation from the 1940s through the present day. In addition, this project captures changes in public interest in environmental issues and in the resource management policies of the DNR, making that content available to students, scientists, policy makers, journalists and the general public.

## Radiocarbon Dating Project

Partner Organizations: Council for Minnesota Archaeology, Minnesota Archaeological Society

**\$7,735**

Radiocarbon dating is an important technique in modern archaeology since it provides objective information about the calendar age of archaeological objects and sites. Through this partnership, the Society's existing archaeological collections were mined for organic samples suitable for radiocarbon dating. The team submitted 13 samples to a radiocarbon laboratory for processing. The results returned by the lab provide a lasting body of information about cultural components at important archaeological sites in Minnesota. In addition, the use of samples from existing collections—some excavated more than 40 years ago—demonstrates the long-term research value of properly preserved archaeological collections.

## MN90: Minnesota History in 90 Seconds

Partner Organization: Association of Minnesota Public Educational Radio Stations (AMPERS)

**\$75,000**

This partnership project with AMPERS, a network of Independent Public Radio stations across Minnesota, has created a series of 130 radio mini-features, 90 seconds in length. Each episode of MN90 educates listeners about Minnesota history and links an important aspect of our past to current news, events and daily life in an entertaining and informative way. The features are airing on at least 11 AMPERS public radio stations, reaching an estimated 240,000 listeners per week.

## Minnesota History Day and Programming at the State Fair

Partner Organization: Minnesota State Fair Foundation

**\$49,800**



Each year, more than 1.75 million people attend the Minnesota State Fair. In 2010, many of these fairgoers gained better knowledge of Minnesota history thanks to the debut of “Minnesota History Day” on September 5 and a highly visible History Walking Tour of the fairgrounds, with new signage and brochures. Historical information and educational programs were held in Carousel Park, directly across from the Grandstand. More than 40,000 people attended Carousel Park programs and more than 15,000 took part in the historic Walking Tour. In 2011, the Society plans to add a cell phone component to the Walking Tour.

## Ojibwe People's Dictionary

Partner Organizations: University of Minnesota, Minnesota Digital Library, Minitex

**\$479,481**

The Ojibwe language, like many other indigenous languages, is endangered. Most current speakers are over the age of 65 and probably fewer than a thousand speakers of Ojibwe in the United States learned it as their first language. Through this project, the partners are creating an Ojibwe dictionary that will be accessible online, serving to create a public and scholarly resource that will preserve and revitalize the Ojibwe language in Minnesota. The interactive, multi-media language and cultural heritage dictionary will link the voices of recorded language speakers to digitized images of cultural objects, photographs, maps, sound and visual recordings and documents from the Minnesota Historical Society. ## Partnerships Outside of the Minnesota Historical Society

### Renovation of the Historic Pine River Depot

Heritage Group North, Inc., Pine River Fire Department and Chamber of Commerce

**\$49,649**

Through this partnership, the Historic Pine River Depot has been upgraded as part of an initiative to transform the unused space into a museum. The Depot, which is located on the Pine River Switchyard—the town’s old railroad station—occupies a highly visible area near the center of the community. This project is a part of a larger plan to revitalize the district. The partners used the ACHF funding to upgrade the building with adequate electrical, climate control, fire protection and security systems. Upgrades were also completed to make the building fully accessible. In 2011, Heritage Group North plans to start converting the Depot into a museum, including turning the old freight room into an interpretive center. The project will prepare the facility to properly store museum collections for future generations to enjoy.

### Northfield History Collaborative

Northfield Historical Society, Carleton College, Northfield Public Library,  
Rice County Historical Society and St. Olaf College

**\$43,950**

The Northfield Historical Society spearheaded this project, which includes creating a central web site portal through which historical content from the community of Northfield can be shared with the public. The ACHF funding is being used to establish a governance and financial model for the Northfield History Collaborative, add new partners and continue digitizing and adding content from new and current partners to the Collaborative site. The Collaborative has also expanded its digitizing efforts to include audio and visual media and plans to orchestrate a community rollout of the web site in 2011. This project is one of the first of its kind in the state to make use of the exciting possibilities of electronic access to collections dispersed among a variety of organizations.

### Mitchell Saloon Historic Structure Report

City of Wykoff, Wykoff Historical Society

**\$10,417**

The Mitchell Saloon is a 19th-century commercial building in the National Register of Historic Places. Built in 1876, the Saloon, now called Ed’s Museum, and its annex, the Wykoff Area Schools Museum, are showing signs of fatigue: clapboard siding needs repair, its foundation is crumbling and the windows are in need of attention. While the City of Wykoff owns this building, it doesn’t have the funds to undertake improvements that respect the historical integrity of the building. ACHF funds are enabling the partners to create a report that will guide future work on the building. With a report that details required improvements, a recommended schedule and expected costs, the Wykoff Historical Society will be able to write grant applications and plan fundraising activities to preserve the building for future generations.

### Story of Suburbanization of Anoka and Hennepin Counties

Anoka County Historical Society, Hennepin History Museum

**\$21,060**

Suburbanization has reached nearly all corners of Hennepin and Anoka Counties. The two counties are bound together by the state’s largest school district: Anoka-Hennepin. Working together, the Anoka and Hennepin County Historical Societies are gathering resources located in numerous repositories so that they, and future historians, will have a logical starting place from which to draw information about the suburbanization of Anoka and Hennepin counties.

## “Legacy Letters” Short Films

1000 Friends of Minnesota, Twin Cities Public Television (TPT)

**\$62,000**

Through this partnership, Minnesota history will be made more accessible to thousands of Minnesotans. The “Legacy Letters” project will result in up to 25 one-minute films that draw their content from a sampling of the 150 people, places, organizations, events and natural features of the state as compiled by the Minnesota Historical Society’s MN150 exhibit and book. Currently 22 “Legacy Letters” air between regular programming on TPT’s Minnesota Channel. This additional round of Legacy Letters will expand and deepen the topics covered in the first round of visual essays to include Minnesota’s history, defined by law as a natural resource.

## Transcription of Ojibwe Footage from “Waasa Inaabida”

Fond du Lac College, Carlton County Historical Society

**\$44,273**

More than 130 Ojibwe tribal leaders were interviewed for the award-winning Waasa Inaabida television documentary series, about the second largest tribe in North America, the Anishinaabe/Ojibwe nation of the upper Great Lakes region. Through this ACHF-funded project, Fond du Lac College, in partnership with the Carlton County Historical Society, will transcribe and catalog the 345 hours of video oral histories, making them available at the two institutions, as well as to a larger audience through online publication.

## Purchase of Historic Property on Leech Lake

Trust for Public Land, Leech Lake Band of Ojibwe

**\$679,710**

This partnership grant is funding the purchase of a 47-acre property on Ottertail Peninsula, Leech Lake, for preservation and management by the Leech Lake Band of Ojibwe. The site, which has been submitted for status in the National Register of Historic Places, includes several burial sites, a fur trading post and the 1770s remnant of one of the first Ojibwe encampments on what is now the Leech Lake Reservation. Without this funding, the land is at risk of development, which would adversely affect the integrity of the site. The ACHF funds are being matched by substantial private donations to help leverage the state’s funding. For more on this land purchase and its significance, see the story on page 12.

## Digitization of Historic Field Notes

Minnesota Geospatial Information Office (MNGeo), Minnesota Secretary of State, Minnesota Department of Transportation (MnDOT), Minnesota Association of County Surveyors (MACS), U.S. Bureau of Land Management (BLM)

**\$585,000**

General Land Office Field Notes were created for the federal government between 1847 and 1911, prior to opening Minnesota to land sale and to European settlement. These highly detailed descriptions of what the surveyors observed and the measurements they performed are the only comprehensive representation of Minnesota’s landscape prior to development. These notes still serve as the legal foundation for all land ownership in the state, and all property titles ultimately rest on these descriptions. Previously, these valuable notes were only available as paper documents, contained in 758 volumes totaling nearly 250,000 pages. Through this partnership and with ACHF funding, digitization of the entire collection of field notes will assist the public with planning and economic development activities by broadening access via the Internet.

## Historic Context for “Neighborhoods at the Edge of the Walking City”

Historic St. Paul, The St. Paul Heritage Preservation Commission and Ramsey County Historical Society **\$100,460**

---

Traditionally, the goal of historic properties surveys is to collect information to make determinations of National Register eligibility or local landmark designation. This ACHF-funded project took that objective a step further. Through its 2010 Saint Paul Survey Project, the partner organizations developed a Historic Context Report for neighborhoods immediately adjacent to the downtown area in targeted areas of the Frogtown, Payne-Phalen and Uppertown neighborhoods. The partners made this information available online, including a database of surveyed properties and PDF files of maps and reports, where it can be used for local planning efforts. The information is providing direction about blocks and properties where preservation should be emphasized and enabling community members to make sound decisions in caring for their properties.

## Interpretive Program about Louise, Hattie and Edith Mayo

It's About Time Theater, The History Center of Olmsted County **\$24,000**

---

While many publications exist on the history of the Mayo Clinic and the Mayo Brothers, little research has been done on the mother and wives of the Mayo family. Louise, Hattie and Edith Mayo had a significant influence, not only on the Mayo Clinic, but on the history of Rochester. Through this partnership, the It's About Time Theater will collaborate with the Olmsted County Historical Society to research and develop a historical play to tell this story. The resulting stage production, “Beyond the Gloves,” will reach audiences through live performances in 2011 and also through digital recordings that can be replayed. The research generated through this project will be available to future generations as a starting point for inquiry about these influential women.









# “Our Minnesota” Exhibit

Funding from the Arts and Cultural Heritage Fund is enabling the Minnesota Historical Society to develop an extensive, hands-on exhibit, designed to bring the rich cultural tapestry of Minnesota into vivid focus. Visitors to the “Our Minnesota” exhibit in the Minnesota History Center will explore the state’s distinctive places and meet the people who have made their homes here. Opening in late 2012, the exhibit will incorporate a wide range of engaging, interactive, story-driven features, supporting the state history standards and complementing the Northern Lights state history textbook. It will also have traveling exhibits to augment the Minnesota Historical Society’s onsite and distance-learning classroom programs.

“Our Minnesota” is being designed primarily for schoolchildren visiting on field trips and for families with children. The exhibit is at the core of a major institutional initiative to reinvent the field trip for 21st-century learners. The exhibit’s themes and topics, as well as the methods designed to engage students in learning about them, are being developed to meet the needs of teachers who are facing dwindling resources for history education and of students who are coming of age in a time of rapid global and technological change. Private fundraising for “Our Minnesota” is underway with several grant requests pending. Fundraising efforts will continue in earnest until the exhibit opens in late 2012.

**APPROPRIATION LANGUAGE:** *Minnesota History and Cultural Heritage Exhibit. \$2,500,000 in 2010 is appropriated to the Minnesota Historical Society for an exhibit on the regional, local, and cultural diversity of Minnesota’s history and cultural heritage. These funds are available until expended. These funds are for the creation of both traveling exhibits to be made available to local historical and cultural organizations and an exhibit to be housed at the Minnesota History Center. The Minnesota Historical Society shall raise funds from private sources to augment this appropriation, with a goal of \$1,500,000 in private funds to be raised. This is not a match requirement, but the Minnesota Historical Society shall certify that a good faith effort has been made.*

# Statewide Survey of Historical and Archaeological Sites

Having current and accurate data on historic and archaeological sites is important to understanding our past and to preserving Minnesota’s history for future generations. In 2010, the Minnesota Historical Society awarded seven contracts for survey projects:

- Survey of Dakota sacred sites in the Twin Cities metro area
- Identification of prehistoric burial mounds in Scott and Crow Wing Counties using LiDAR (Light Detection & Ranging)
- Archaeological survey of Olmsted County
- Archaeological survey of Swift County
- Archaeological survey of the North Shore in Carlton, Cook, Lake and St. Louis Counties
- Archaeological field survey of southwestern Minnesota to discover sites that hold the state’s earliest cultural history
- Investigation and research of unrecorded historic cemeteries in Minnesota

Representatives of the Minnesota Historical Society, the Office of the State Archaeologist and the Minnesota Indian Affairs Council oversaw these projects.

**APPROPRIATION LANGUAGE:** *Statewide Survey of Historical and Archaeological Sites. \$250,000 in 2010 and \$250,000 in 2011 are appropriated to the Minnesota Historical Society for a contract or contracts to be let on a competitive basis to conduct a general statewide survey of Minnesota’s sites of historical, archaeological, and cultural significance. Results of this survey must be published in a searchable form, available to the public on a cost-free basis. The Minnesota Historical Society, the Office of the State Archaeologist, and the Board of Indian Affairs shall each appoint a representative to an oversight board, to select a contractor and direct the conduct of this survey. The oversight board shall consult with the Minnesota Departments of Transportation and Natural Resources. Funds appropriated for this purpose do not cancel and may be carried over from one year to the next.*

# Minnesota Digital Library

The Minnesota Digital Library (MDL) is a statewide, multi-institutional initiative to make the rich historical resources of the state’s public and academic libraries, archives, museums and historical societies available to the public via the web and to preserve the resources for future generations. The MDL complements the public access to the book catalogs and indexes to the collections of these institutions currently provided by the MnLINK (Minnesota Library Information Network) Library Gateway and the Electronic Library of Minnesota (ELM).

The ACHF-funded Minnesota Digital Library project is enabling the Minnesota Historical Society to work with key partners, including the University of Minnesota and Minitex, to create a repository for the permanent preservation of important historical materials converted to digital form. The partner organizations are working with a consortium of universities involved in digital preservation to advance the technical, administrative and governance issues of this cooperative venture.

This project is also enabling the Society and its partners to expand support for the Minnesota Reflections web site, [reflections.mndigital.org](http://reflections.mndigital.org), a site developed and maintained by the MDL. Since the funds have been allocated, the number of images and documents that are available on the site has increased by more than 75 percent to 58,000 from 33,000. These files, which can be accessed by the public at no cost, were contributed by more than 115 organizations across the state.

**APPROPRIATION LANGUAGE:** *Digital Library. \$500,000 in 2010 is appropriated for a digital library project to preserve, digitize, and share Minnesota images, documents, and historic materials. The Minnesota Historical Society shall cooperate with the Minitex system and shall jointly share this appropriation for these purposes.*
